HOLD THAT APPROVAL broke in at the start bumping with FULFILLING DREAM, recovered to chase the early pace from the outside, made a bid entering the drive, dueled through the stretch and proved best after a stretch long drive. After a Jockey's Objection and review by the Stewards', HOLD THAT APPROVAL was disqualified for interference leaving the starting gate. TOKIN ESSENCE stalked the early pace from the outside, made a bid entering the drive, dueled with the winner but was outfinished. FULFILLING DREAM was bumped at the start, then well placed from the outside, made a bid entering the drive and finished with a late effort. MAKIN A RUN chased the early pace inside but could not keep pace. CAREFREE HERO could only pass tired ones. LOVERULESTHEWORLD broke well from the outside to gain a clear early margin, tired in the drive. DISTINGUISHED was no threat. SPIRIT OF SEATTLE was no factor. WICKED DEVIL was never close. BROADWAY AL had a steady fade.
