

# TENTH RACE Lone Star May 12th, 2007

1 1/4 MILES. (1.402) STAKES. Purse \$300,000 *LONE STAR DERBY(GRADE III)* (PLUS UP TO \$12,000 Open ATB) FOR THREE YEAR OLDS. No nomination fee. \$2,250 to pass the entry box and an additional \$2,250 to start with \$300,000 guaranteed of which \$165,000 to the owner of the winner, \$55,000 to second, \$30,250 to third, \$16,500 to fourth, \$8,250 to fifth and \$5,000 for placing sixth through tenth. If less than ten horses start, the purse money not distributed will revert to the winning owner. Weight: Colts and Geldings, 122 lbs. Fillies, 117 lbs. Starters to be named through the entry box by the usual time of closing. In allowance stakes, starting preference will be given to horses that have accumulated the highest earnings at time of entry. The field will be limited to fourteen starters. Horses not drawing a starting position in the gate will receive a refund of the entry fee. The winning owner, trainer, and jockey to receive a trophy. Nominations closed Thursday, May 3, 2007 with 26 nominations. (Clear 80)

SLEW'S TIZZY raced three wide on the first turn, was well placed behind the leader, engaged those rivals while four wide on the far turn, battled with MR. NIGHTLINGER into the final furlong then edged clear under strong handling. MOYER'S POND settled towards the rear of the field, moved between rivals near the half-mile pole, was urged along while four then five wide on the far turn and finished well for the place. FORTY GRAMS broke a bit slow then was in tight early, raced three wide on the first turn, settled well off the pace, was blocked from the five-sixteenths pole to the quarter-pole, had the rider lose his whip in upper stretch, altered course to the inside near the furlong marker and finished well in a brutal trip. MR. NIGHTLINGER contested the pace on the inside of TAKSENT while off the rail, battled gamely into the final furlong then gave way grudgingly. REPORTING FOR DUTY raced well back in the field, was urged along on the backstretch, lacked room while three wide midway through the far turn, came four wide into the stretch, split rivals while in tight near the sixteenth-pole and lacked the needed rally. TAKEDOWN settled near the inside, saved ground on the far turn and lacked the needed response. REATA'S ROCKET broke very awkwardly then was shut-off, raced four wide on the first turn, was urged along on the outside of HARROW LAND, bumped with that rival leaving the backstretch, chased five wide on the far turn and came up empty. SLEW BY SLEW raced four wide on the first turn, settled on the outside, was urged along while five then six wide on the far turn and failed to threaten. TAKSENT raced three wide on the first turn, contested the pace on the outside, came up empty while three wide on the far turn and retreated. HARROW LAND went three wide on the first turn, was urged along on the inside of REATA'S ROCKET, bumped with that rival leaving the backstretch, raced three then four wide on the far turn, was in tight while dropping back entering the stretch and stopped then was eased in the final furlong but walked off.
