The Owner of the winner to receive \$60,000, \$20,000 to second, \$11,000 to third, \$6,000 to fourth and \$3,000 to fifth. Weight: 121 lbs. Non-winners of \$35,000 twice at a mile or over allowed 3 lbs.; \$35,000 at a mile or over, 5 lbs.; \$25,000 or a race at a mile or over other than Maiden, Claiming, or Starter, 7 lbs. Gra ded placed horses of equal weights preferred. A trophy will be presented to the winning Owner. This race will be limited to 12 Starters, with Also Eligibles (High Weights Preferred). CHRISTMAS KID rated just off the early pace inside, was hemmed on the hedge through the final turn, angled four wide rallying into the lane, dueled from the sixteenth pole and inched ahead toward the wire. PERFECT MOTION rated off the pace about the three path, bid midway through the final turn, dueled clear toward the eighth pole then reluctantly yielded to the winner toward the wire. LISA M rated off the pace, was boxed in through the final turn, angled five wide into the lane and finished well to show. SNOW CONE, unhurried inside, was prompted for run into the final turn, blocked at the quarter pole, eased out into the lane and closed evenly. CAT CHARMER showed no speed outside, swung out entering the lane and finished evenly widest. GO NATIVE showed no speed outside, entered the stretch seven wide and finished evenly. CHANGEISGONNACOME rated a slim lead inside, dueled into the stretch and weakened approaching the eighth pole. SILKILY showed no early speed from off the rail and tired saving ground on the final turn. IN FOR A DIME was outrun. SECRETSOFTHEHEART rated close two deep, bid into the final turn, dueled from the top of the stretch and weakened at the eighth pole. FIESTIVE EVENT rated close off the hedge and gave way from the final turn. NASEEM gave chase from off the hedge, was carried out entering the lane and gave way from there.
