ALLSWELLTHATNSWELL chased outside a rival then off the rail, came a bit wide into the stretch and bested the others. GN. GROUP MEETING settled outside then off the rail, also came a bit wide into the stretch and did not rally. COTORRA saved ground chasing the pace, split horses leaving the turn then lacked a rally inside. LADY BERTRANDO between foes early, dueled inside, dropped back into and on the turn and gave way.
