PINE ISLAND broke in a bit at the start, was unhurried early while saving ground, moved to the outside midway down the backstretch, advanced four wide at the half mile pole, angled back to the inside on the far turn, waited briefly on the turn, split horses to launch her bid nearing the quarter pole, swung four wide entering the stretch, took up chase after TEAMMATE in midstretch then closed steadily in the middle of the track to get up in the final seventy yards. TEAMMATE alternated for the lead along the inside for a half, opened a clear advantage on the far turn, maintained a clear advantage into upper stretch, battled gamely into deep stretch but couldn't hold the winner safe. LEMONS FOREVER was outrun for seven furlongs, swung out on the turn, advanced six wide into the stretch and closed late in the middle of the track to gain a share. UNBRIDLED BELLE raced within striking distance while four wide along the backstretch, remained a factor to the turn and steadily tired thereafter. ADIEU raced in close contention between horses to the turn, drifted out in upper stretch and faded in the drive. WONDER LADY ANNE L raced up close in hand while saving ground, angled out on the far turn, lodged a mild bid from outside on the turn then faltered in the stretch. MISS SHOP raced in the middle of the pack while four wide throughout and lacked a strong closing bid. EX CAELIS in hand early while saving ground, made a run along the inside to reach contention on the turn then lacked a further response. PYRAMID LOVE contested the pace from outside for five furlongs, dropped back on the far turn then gave way and was eased in the stretch.
