Chestnut Gelding, (May), by City Zip - Citi Pearl by Citidancer. Trainer Stidham Michael. Bred by Amy Bondon & Tom McNally(KY). WORKIN FOR HOPS, never far back, moved to terms with the pacesetter while in hand in the opening quarter, attended that foe's pace under some reserve to the far turn, readily took charge leaving the second bend to open a commanding advantage and held sway on a clear margin to the end under a right handed tap and hand urging. MISTER MARTI GRAS was settled outside foes in the opening stages, continued unhurried to the second bend, gathered momentum switching outside foes nearing upper stretch, angled five wide in the lane while making steady progress, exchanged some contact with GLEAM OF HOPE leaving the sixteenth marker but continued with interest to earn the place. DEAN'S KITTEN, caught outside the second flight in the opening quarter, worked his way to the inside on the first turn while under reserve, shifted out after five furlongs, advanced to striking distance racing three wide between foes into upper stretch, momentarily shifted into the path of GLEAM OF HOPE making some contact with that foe nearing the sixteenth marker but continued well enough to earn a share. GLEAM OF HOPE was settled off the inside in the opening half, advanced with a smart move racing four wide on the far turn, bid between foes in that path leaving midstretch, but lost some momentum when bumped, then shuffled back leaving the sixteenth marker. MINT CHIP, held up out of tight quarters at the start, saved ground tracking the pace unhurried to the far turn, then shifted out in the lane to pass some tiring rivals. ASPHALT, pulling a bit racing between foes in the second flight to the backstretch, came up empty nearing upper stretch. DREAM NETTIE tracked the leaders three wide in second flight for a half, advanced in that path to briefly challenge racing through the far turn but flattened out nearing midstretch. MARCELLO broke outwards, was quickly collected while moving to the lead from between foes, dictated the pace along the rail to the far turn and emptied out when failing to match terms with the winner nearing upper stretch. FORMULAFORSUCCESS secured a forward placing along the inside soon after the break, stalked just off the leaders along the rail but steadily faded from contention leaving the far turn. FOLLOWING THE RACE THE ASSISTANT TRAINER OF GLEAM OF HOPE LODGED A CLAIM OF FOUL AGAINST THE RIDER OF DEAN'S KITTEN. THE STEWARDS CONDUCTED AN INQUIRY AND DISQUALIFIED DEAN'S KITTEN FOR INTERFERENCE, PLACING HIM FOURTH.
