The owner of the winner to receive \$450,000, with \$150,000 to second, \$90,000 to third, \$45,000 to fourth and \$15,000 to fifth. Weights: Northern Hemisphere: 121 lbs. WAIT A WHILE pulled a bit early, stalked outside a rival, moved up boldly three deep leaving the second turn and was bumped nearing the quarter pole, took command, angled in and drove clear under some left handed urging. ASAHI RISING (JPN) chased inside then came off the rail approaching the first turn, stalked outside on the backstretch, went up four wide into the second turn then advanced three deep leaving that turn and into the stretch and gained the place late. ARRAVALE chased inside then a bit off the rail, moved up outside on the second turn and three deep a quarter mile out, angled in a bit into the stretch and lost second late. GALILEO'S STAR (IRE) angled in and settled inside, came a bit off the rail in the lane, split rivals late and improved position. SOL MI FA (IRE) saved ground stalking the pace, fell back some on the second turn and weakened. FOXYSOX (GB) stalked the pace off the rail, bid outside the pacesetter leaving the backstretch, was bumped and steadied leaving the second turn and had the rider briefly lose the left iron and also weakened. PROXENIA (GB) angled in and chased outside a rival, came out some in the stretch and did not rally. ATTIMA (GB) sped to the early lead, set the pace inside, came out some and bumped with FOXYSOX leaving the second turn, came a bit off the rail in the stretch and had little left. A claim of foul by the rider of FOXYSOX against the winner for alleged interference leaving the second turn was not allowed by the stewards, who ruled ATTIMA caused the trouble.
