CAMELOT KITTEN settled off the pace and towards the inside, gathered momentum leaving the far turn, cut the corner into the lane, found room to rally along the rail nearing the eighth pole, drew on even terms soon after, battled nose to nose with BEACH PATROL to his outside, came out slightly leaving the sixteenth marker, corrected under strong handling and got the bob at the wire. BEACH PATROL drafted in behind the three leaders nearing the first turn, rated kindly past the five eighths, picked up the pace when given his cue leaving the far turn, shifted out four wide approaching the stretch, ranged up to draw even leaving the furlong grounds, fought it out gamely and lost a tough one on the wire. SURGICAL STRIKE, unhurried early while removed from the inside, came six wide for the drive, drifted in slightly past the furlong grounds then closed nicely. AIROFORCE moved clear from the inside after a quarter mile and set the pace, felt pressure from a pair of foes mid way down the backstretch, was engaged in a duel with SHAKHIMAT around the final turn, shook that one off to go clear off the inside three sixteenths out, was joined from both sides nearing the eighth pole, could match strides then steadied when in close leaving the sixteenth marker. AZAR, three to four wide off the pace, came under pressure leaving the far turn, steadily progressed in mid stretch then failed to seriously sustain his bid. CONVERGE, three wide under a rating hold entering the backstretch, moved up into the lane, continued a run between foes nearing the eighth pole, angled in and came up empty late. DRESSED IN HERMES lacked speed, came seven wide for the drive and had a belated gain. J R 'S HOLIDAY saved ground early, steadied off heels when angling out past the five furlong pole, altered back in, saved ground into the lane then had to steady behind rivals while having some run near the furlong grounds. SHAKHIMAT bobbed inward and bumped with TWO STEP TIME, straightened and moved up four wide into the first turn to entertain the pace, dropped in a path or two and applied more pressure past the five eighths, dueled outside AIROFORCE to the quarter pole then succumbed. AMERICAN PATRIOT broke a step slow, raced off the rail and failed to menace. TWO STEP TIME was bumped at the break, rated off the pace, swung wide for the drive and failed to threaten. CUTACORNER saved ground and weakened. FRANK CONVERSATION was a bit keen attending the pace two to three wide, steadied back off of foes past the five eighths, angled out to chase, kept on to the quarter pole then faltered.
