1 MILE. (Turf) (1.33²) STAKES. Purse \$100,000 APPALACHIAN S. (GRADE III) FOR FILLIES, THREE YEARS OLD. By subscription of \$100 each, which should accompany the nomination. \$500 to enter and an additional \$500 to start, with \$100,000 guaranteed, of which \$60,000 to the owner of the winner, \$20,000 to second, \$10,000 to third, \$5,000 to fourth, \$3,000 to fifth, and \$2,000 to be divided equally among sixth through last. Weight: 123 lbs. Non-winners of a graded stakes at a mile or over on the turf allowed 2 lbs.; \$45,000 at a mile or over since October 9, 4 lbs.; two races at a mile or over other than claiming, 6 lbs. Starters to be named through the entry box by the usual time of closing. A gold julep cup will be presented to the owner of the winner. Closed Wednesday, April 7, 2010 with 26 nominations. In the event that this race is taken off the turf it will be contested at Eight and One Half Furlongs on the main track. (Clear 84)

CHECK THE LABEL tracked the pace three deep, took closer order through the second turn, took over entering the stretch, kicked clear and held sway under steady urging. BAY TO BAY angled in to save ground, shifted to the outside nearing the three-eighths pole, advanced circling five wide, continued on well and was making up ground readily. ROSE CATHERINE opened clear to dictate terms, was collared before going a half, set the pressured pace to the stretch but weakened in the final furlong and faded. ORCHESTRATOR was forwardly placed along the inside, got through entering the stretch but lacked a response when called upon. ALL COUNTY was allowed to settle along the inside, angled out to make a mild rally but failed to threaten. RED HOT BUDDHA settled in hand, came four wide but went evenly through the drive. GO ASK ALEX broke a step slow, rushed to the lead four wide, contested the pace for six furlongs and tired. CACTUS CADILLAC trailed.
