Supplementary nominations may be made by Friday, April 6, 2018 at \$500. \$700,000 Guaranteed of which 60% to the Owner of the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth and 2% to be divided equally between remaining starters. Weights to be announced Saturday, April 7, 2018. In Handicap Stakes starting preference will be given to high weights. Starters to be named through the entry box by the usual time of closing. Bay Mare, (Apr), by Uncle Mo - Unbridled Waters by Unbridled. Trainer Todd A. Pletcher. Bred by Red Oak Stable (KY).

UNBRIDLED MO, held up off a rival racing into the first turn tracking the pacesetter out of striking distance into the backstretch, shifted off the inside on the far turn gathering momentum, angled four wide nearing upper stretch while being prompted to advance, moved to wrest the advantage under left handed pressure leaving midstretch and went clear. UNIQUE BELLA, a bit restless in the gate prior to the start, bobbled at the break losing position to the field, switched outside foes racing into the first turn while pulling her way to a contending position tracking just off the pacesetter, took over a half, was prompted to maintain the lead racing into upper stretch but proved no match when confronted by the winner while clearly best of the others. FUHRIOUSLY KISSED settled well off the leaders while angling to the rail in the opening stages, saved ground to upper stretch and responded to firm encouragement to gain a share inside foes nearing the wire. STREAMLINE angled to the inside in the opening stages while gaining a position tracking just off the pacesetter, continued in that fashion for a half, shifted out three wide leaving the midway point of the far turn while being prompted to bid for command between foes racing into upper stretch but lacked the needed final kick. TIGER MOTH settled in hand while being switched off the inside in the opening stages, angled five wide racing into the stretch but made no real impression. BEACH FLOWER settled into stride racing off the inside to the backstretch and failed to seriously menace. FARRELL was urged clear while angling to the rail racing into the first turn, set the pace for a half, continued under pressure in pursuit of the pacesetter racing through the far turn but faded entering upper stretch.
