By subscription of \$100 each which shall accompany the nomination, \$1,000 to pass the entry box and an additional \$1,000 to start - with \$100,000 guaranteed. SOLDIER'S DANCER unhurried early, rallied three wide around the far turn to take over entering the stretch, then drew off under urging. VILLAINAGE allowed to settle, came between horses on the far turn, then closed along the inside to be up for the place while no match for the winner. STORM IN MAY showed speed along the hedge into the far turn, steadied from close quarters at the quarter pole, angled out and gave way. TUXEDO'S PARADISE rated off the pace, steadied in traffic on the backstretch, raced three wide around the far turn, then couldn't keep pace in the drive. BLUE SAILOR chased the pace, moved to gain a slim lead on the far turn, made the pace to nearing the stretch, then tired. SAINT PAUL showed speed outside STORM IN MAY into the far turn, then faltered. DARBY'S PAL hit the gate at the start, then checked along the inside in the early going and was not a factor. WORLD WAR steadied along the inside in the early going, tracked the pace along the hedge into the stretch, then had nothing left. HAL'S MY HOPE was done early. LEGENDS WAY reserved off the pace, raced four wide on the far turn and faded.
