TAMBORIM stalked the pace three wide, rallied to gain the lead inside the eighth pole, opened a clear lead inside the sixteenth pole, then was all out to last over ADARI. The latter, unhurried while saving ground, swung out for the stretch run and rallied to just miss. THIS ONES FOR PHIL bumped with EDGEMOOR at the start, vied for the lead outside CODE RUNNER, continued to make the pace to inside the eighth pole, then gave way. EDGEMOOR rated off the pace after bumping with THIS ONES FOR PHIL at the start, advanced to reach contention in the stretch and hung. IT'S OUT THERE chased the pace into the far turn and tired. CODE RUNNER vied for the lead along the rail, then faltered in the drive. NOSTRINGSATTACHED steadied leaving the first turn and was done early.
