1 1/4 MILE. (1:41) STAKES. Purse \$500,000 Central Bank Ashland S. (Grade I) FOR FILLIES THREE YEARS OLD. By subscription of \$100 each on or before February 16, 2019 or \$1,000 each on or before March 20, 2019. A Supplementary Nomination of \$15,000 each may be made at time of entry (includes entry and starting fees). \$2,500 to enter and an additional \$2,500 to start, with \$500,000 guaranteed, of which \$300,000 to the owner of the winner plus 100 Road To The Kentucky Oaks Points, \$100,000 to second plus 40 Road To The Kentucky Oaks Points, \$50,000 to third plus 20 Road To The Kentucky Oaks Points, \$25,000 to fourth plus 10 Road To The Kentucky Oaks Points, \$15,000 to fifth and \$10,000 to be divided equally among sixth through last. Weight: 121 lbs. The maximum number of starters for the Central Bank Ashland will be limited to fourteen. In the event that more than fourteen pass the entry box, the fourteen starters will be determined at that time with preference given to graded stakes winners (in order I-II-III), then highest earnings. Starters to be named through the entry box by the usual time of closing. Keeneland will present a trophy cup to the winning owner. A silver julep cup will be presented to the winning trainer and jockey. Closed Saturday, February 16, 2019 with 101 nominations. (Clear 67)

OUT FOR A SPIN broke alertly to be forwardly placed three wide to the first turn, shadowed JAYWALK from the outside up the backstretch, challenged between that one and RESTLESS RIDER to take a short lead past the midway point on the far turn, went stride for stride with the latter into the stretch, and dug in gamely for a hard-fought decision. RESTLESS RIDER settled within range of the early pace two wide, moved out three wide to join the leaders midway on the far turn, reached near-even terms outside OUT FOR A SPIN into the lane, but hung late. JAYWALK bumped with LADY KATE at the start, came away with the lead two wide into the first turn, moved inside being hounded by OUT FOR A SPIN through the middle splits, and yielded to the top two finishers approaching the stretch. BIZWHACKS moved off the inside leaving the first turn at the back, took the far turn three then four wide, and had no solid response. LADY KATE bumped with JAYWALK while breaking a bit awkwardly, saved ground reserved early, came two wide off the far turn and did not menace. CHOCOLATE KISSES was never prominent inside. BELL'S THE ONE showed brief speed four wide, dropped back after a half-mile and was not pressured after six furlongs.
