No nomination fee, original nominators paying \$1,000 to pass the entry box and \$1,500 additional to start. Supplementary nominations may be made by closing time of entries at a fee of \$3,500 which qualifiesto start with \$300,000 Guaranteed. To be divided 60% to the Owner of the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth and 2% to be divided equally among all other starters. Weights: 122 lbs. Non-winners of \$60,000 twice at a mile orover since August 14, 2014 allowed 3 lbs.; \$50,000 once at a mile or over since September 14, 2014, allowed 5 lbs.; \$40,000 at a mile or over in 2014-2015 allowed 7 lbs.; \$25,000 at any distance in 2015, allowed 9 lbs. GOLD MEDAL DANCER bounded away and showed the way past the wire the first time off the inside, settled comfortably and continued to show the way up the backstretch off the inside, responded when confronted late in the second turn from the outside, long drive while angling to the inside, proved best in game fashion. **UNTAPABLE** a bit restless in the gate prior to the start, broke with the field, forwardly placed toward the inside into the first turn, rank, slow to settle, shifted out to flank the winner, continued to prompt that rival from the outside the middle half mile, tried that foe turning for home, dueled to the wire, outkicked in the late going. **MUFAJAAH** trailed and unhurried, roused in the five path exiting the final turn when beginning to advance, staged a mild rally past the furlong marker, flattened out a bit in the late going and did not seriously threaten the top two in the late going. **DIVA'S DIAMOND** one paced in the three path under light restraint, asked from between rivals entering the stretch, failed to make an impact. **FLASHY AMERICAN** allowed the pace go, continued behind the top two the middle half in the two path, asked, also lacked a significant response in the drive.
