ABACO bumped lightly at the start with STRATHNAVER, rated three wide towards the rear behind the cover of FILIMBI, came under a ride at the five-sixteenths, angled five wide into upper stretch into the clear, rallied into contention inside the eighth pole with good kick, latched on and matched strides with STRATHNAVER through the final sixteenth and took over in the final strides to prevail. STRATHNAVER (GB) bumped lightly at the start by ABACO, rated just off the inside near the rear behind the cover of CENTRE COURT, came under coaxing at the five-sixteenths, spun three wide for home set down in earnest out of the cover of CENTRE COURT, rallied to be the main threat a furlong out and took over inside that juncture, dug in under challenge from ABACO, knocked heads with that rival to the line and was caught in the final strides and forced to settle for the place. NELLIE CASHMAN tracked the pace along the inside in close range behind the cover of the leader NIGHT SONG, came under urging at the five-sixteenths, spun just off the inside for home and shifted to the hedge vacated by the leader straightened away leaving the cover into upper stretch, rallied to be heads apart a furlong from home, offered up a mild kick through the final furlong to procure the show. CENTRE COURT attended the pace maker just off the inside in hand, got let out swinging three wide for home and was bumped lightly by NIGHT SONG as that foe drifted slightly straightened away, dug in taking narrow command just outside the eighth pole, got headed inside that marker and was out kicked thereafter. NIGHT SONG away well, crossed to the hedge into the first turn establishing the front, showed the way in hand under no direct pressure while setting sensible fractions, remained patiently handled until nearing the quarter pole, cut the corner set down for the drive and drifted to the two path straightened away lightly bumping with CENTRE COURT, yielded the front to that foe just outside the eighth pole and weakened in the final furlong. FILIMBI three wide through the first turn, remained three wide down the backside in hand in close range of the front, came under coaxing at the five-sixteenths in tandem with her rivals, angled four wide into upper stretch and came up empty.
