Weight 122 lbs. Non-Winners of \$55,000 at a mile or over in 2009 allowed 2 lbs.; \$35,000 twice at a mile or over in 2009, 4 lbs.; one such race, 6 lbs. (Maiden, claiming and starter races not considered in estimating allowances). Trophy to the winning owner, trainer and jockey. Closed Sunday, July 5, 2009 with 29 Nominations. (Clear 80)

OUR EDGE broke sharp and moved to the inside when clear early, shook loose at the top of the stretch then was roused well into the final furlong to prove best. IT HAPPENED AGAIN moved up menacingly with a three wide bid on the far turn then couldn't sustain his rally. DENVER was well placed racing close to the pace and lacked the needed rally. SUMO moved up between rivals leaving the far turn then lacked more. IN THE JUICE got out around the first turn then continued willingly. CODE OF HONOUR raced close up along the inside early then lacked a solid rally. DOC'S FRIEND moved closer on the far turn then flattened out in the drive. SUDDEN SHIFT showed little. PITCHED PERFECTLY prompted the pace to the far turn then gave way. DUMAR failed to threaten. SLEW OF SMOKE was through early.
