7 FURLONGS. (1.20²) STAKES. Purse \$70,000 **BARRETT'S S. FOR THREE YEARS OLD AND UPWARD, BRED IN CALIFORNIA, WHICH HAVE NOT WON \$7,500 OTHER THAN MAIDEN, CLAIMING OR STARTER OR HAVE NEVER WON TWO RACES.** By subscription of \$50 each, on or before Friday, April 4 or by supplementary nomination of \$1,400 each by closing time of entries. Closed with 1. \$100 to start, with \$42,000 to the winner, \$14,000 to second, \$8,400 to third, \$4,200 to fourth and \$1,400 to fifth. Weights: Three year olds 118 lbs; Older 124 lbs. Non-winners of a race other than maiden, claiming or starter, allowed 2 lbs; non-winners of a race other than claiming or starter, 4 lbs. Gray or Roan Gelding, (Apr), by Lit de Justice - Undressed by Black Tie Affair (IRE). Trainer McFarlane L. Dan. Bred by Paul Boghossian(CA).

BESTDRESSED reserved early, advanced three then four wide into the stretch, rallied strongly from far outside and inhaled rivals late. SWISS SKI stalked from between foes and then three wide into the stretch, rallied between foes, gained brief lead in deep stretch but was overhauled. DR ZAENTZ lagged back, advanced from between foes then two wide leaving the turn, rallied strong between rivals late then was bumped nearing the wire. EARNEDNEVERGIVEN settled while angling in some, later found the fence and rallied strongly in the final sixteenth. MAUI MARK prominent while outside foe, remained bit off the fence leaving the turn, loomed through the drive, lugged inward and bumped inside rival nearing the wire. PARTYWITHLARRYZ unhurried while saving ground, split foes in upper stretch then angled out and improved placing. CALIFORNIA FLAG forced the early pace along the rail, gained slim advantage in upper stretch, edged away but was swarmed through the drive and lost placing. ANZISONG saved ground throughout but failed to reach contention. TWO TONE ROAN flashed good early foot, dueled or set pace outside rival to the stretch then weakened. MIDNIGHT EXCESS angled in, later found the fence and failed to menace. PUBLIC IMAGE reserved from the outside, continued wide and was never a serious factor. ONE ON THE HOUSE reserved off the pace, chased three then four wide to the stretch and never rallied. KINETICAT YANKEE moved up some outside, caught five wide entering the stretch and also weakened. CREDIBILITY forced the early pace well off the rail, dropped back and gave way.
