CIRCULAR QUAY, sluggish to begin, worked his way near the inside, was steadied behind ELITE SQUADRON about the three-eighths pole, came around that rival when advancing into the stretch, angled back to the rail in the late going, then finished full of run to edge clear at the end. **SHERMANESQUE**, well placed from early on while near the inside, angled four wide entering the stretch, reached the front between calls in the final furlong but wasn't a match for the winner late. **RUN ALEX RUN** drifted in soon after the start bumping soundly with **PEGASUS WIND**, stalked the pace four wide, loomed menacingly for the last eighth and came up empty. **TEUFLESBERG** stumbled at the start, came up running to gain the lead, raced two or three wide, made the pace into the final furlong and tired. **PEGASUS WIND**, bumped soon after the start by **RUN ALEX RUN** when that one leaned in, went up soon after to press front-running **TEUFLESBERG**, battled forwardly into mid-stretch and weakened. **CHACE CITY** broke in the air, lost his footing when landing, swerved in badly, attempted to jumped the portable railing leaving the chute, was outrun to the stretch and couldn't menace while seven wide in the drive. **ELITE SQUADRON** raced in contention near the inside to the stretch and weakened. **MISTER CUGAT**, near the inside and lightly steadied three furlongs out, faded soon after.
