GENERAL ELECTION settled in the second flight five wide, ranged into contention on the second turn, was fanned eight wide into the stretch, kicked on well despite the wide go, struck the front with a furlong to run and held stubbornly. **GIANT FINISH** attended the pace four wide, drew even on the second turn, poked his head in front with five-sixteenths to run, drifted out entering the stretch bumping **STORMIN MONARCHO** near the three-sixteenths pole, was straightened away and fought on but was unable to resist the winner. **FOR GREATER GLORY** was allowed to settle, took closer order through the second turn, was blocked entering the stretch, bumped with **TAKIN THE SOLOROAD** near the three-sixteenths marker, angled in and continued on willingly. **TAKIN THE SOLOROAD** settled in hand four wide, moved into striking distance nearing the quarter pole, was bumped entering the stretch when **FOR GREATER GLORY** lacked room, and flattened during the drive. **STORMIN MONARCHO** was forwardly placed along the inside, shifted out four wide entering the second turn, drew even near the quarter pole, was bumped when **GIANT FINISH** came out entering the stretch, was hemmed in through the drive and went evenly. **LET'S RUN** broke slow, was allowed to settle, circled five wide and improved position. **BYE BYE BERNIE** tracked the pace three wide, bid between horses, contested the issue two wide then inside, but came up empty entering the stretch and dropped out. **SILVER TONGUED** failed to respond. **MELLOW FELLOW** broke outward, bumped **ADMIRAL KITTEN** at the start, sped clear to set the pace, was collared on the second turn and gave way readily once headed. **AVARE** was allowed to settle between horses and lacked a response. **ADMIRAL KITTEN** stumbled at the start, was bumped hard when **MELLOW FELLOW** came out, toiled at the back of the field and never recovered.
