Chestnut Filly, (Mar), by City Zip - Be Envid by Lemon Drop Kid. Trainer Ian Kruljac. Bred by HnR Nothhaft Horseracing, LLC (PA).
FINEST CITY, with the pace three deep and under some rating, moved to a slim lead in upper stretch, responded when set down soon after, was hooked confronted from her outside by **WAVELL AVENUE** leaving the eighth pole, dug in tenaciously under left handed encouragement and held firm. **WAVELL AVENUE** rated five wide while not too far back, made a bold five wide move into the lane, ranged up to threaten in mid stretch, kept on willingly but could not get past. **PAULASSILVERLINING** vied three wide between rivals, shifted in soon into the lane, kept up the fight past the furlong grounds then gave way grudgingly. **TARA'S TANGO**, forwardly placed between rivals, shifted out under pressure leaving the three sixteenths and kept trying to the wire. **BY THE MOON** tracked inside, came out some around the turn while still close up, had aim between rivals into the stretch but lacked a solid finish. **SPELLING AGAIN**, away alertly, stalked the pace four wide, was under a hustling ride past the five sixteenths but failed to generate a serious response. **HAVEYOUONEAWAY** saved ground leaving the far turn while in range, eased out in upper stretch but lacked the needed kick. **IRISH JASPER** settled off the early pace while removed from the rail, angled further out making a bit of a run mid turn, circled five wide into the stretch but failed to sustain. **CARINA MIA** rated between runners while off the early pace, came wide for the drive and failed to be a threat. **WONDER GAL** hustled up soon after the break to give chase, steadied between rivals leaving the far turn, swung out for the drive and had a slight re-bid. **GLORYZAPPER** was sent up between foes early and gained a slim lead, dueled inside a pair of rivals, secured the rail around the turn, kept on to the quarter pole then gave way. **PAOLA QUEEN** angled off the inside early on, was under pressure leaving the far turn and faltered. **GOMO**, between rivals early, angled in for the run around the turn, faltered and was eased in the final furlong.
