

EIGHTH RACE **Keeneland** **April 13th, 2014**

About 7 FURLONGS. (1.24¹) STAKES. Purse \$200,000 *BEAUMONT S. PRESENTED BY KEENELAND SELECT (GRADE II) FOR FILLIES THREE YEARS OLD.* By subscription of \$100 each, which should accompany the nomination or by Supplementary Nomination of \$15,000 at time of entry (includes entry and starting fees). \$1,500 to enter and an additional \$1,500 to start, with \$200,000 guaranteed, of which \$120,000 to the owner of the winner, \$40,000 to second, \$20,000 to third, \$10,000 to fourth, \$6,000 to fifth and \$4,000 to be divided equally among sixth through last. Weight: 123 lbs. Non-winners of a Grade I stakes allowed 3 lb s.; a Grade II stakes or \$60,000 twice, 5 lbs. Certain finishing positions in this race will earn points to qualify for the 2014 Kentucky Oaks, pursuant to the official rules for the Kentucky Oaks published by Churchill Downs Incorporated. The maximum number of starters for the Beaumont will be limited to fourteen. In the event that more than fourteen fillies pass the entry box, the fourteen starters will be determined at that time with preference given to graded stakes winners (in order I-II-III), then highest earnings. Starters to be named through the entry box by the usual time of closing. Keeneland will present a trophy cup to the winning owner. Closed Wednesday, March 26, 2014 with 43 nominations. (Clear 73)

READY TO ACT was bumped at the start and a step slow into stride, shifted out five to be clear, ranged into striking distance through the turn, drew even entering the stretch, lugged in through the drive but was held true to narrowly prevail. **SWEET WHISKEY** contended between horses in hand, angled in entering the stretch, kicked on well but was kept at bay. **KATIE'S EYES** prompted the pace three wide, battled on gamely through a prolonged drive but grudgingly gave in late. **RICHIES PARTY GIRL** was away alertly, set the pace off of the inside, was collared between rivals entering the stretch and weakened during the drive. **TEA TIME** was close up along the inside, angled out leaving the turn but came up empty in the drive. **CONSPIRED** settled in hand three wide, tipped out five wide entering the stretch but lacked a response when called upon. **CO COLA** tracked the pace four wide, but faltered leaving the turn and retreated.
