DANCE TO BRISTOL stumbled slightly at the start, settled three wide within aim in hand, ranged up to take closer order nearing the quarter pole given some rein to work with, got roused at the head of the stretch, collared the leading pair a furlong out, edged away through the final sixteenth under a drive to prevail. FANTASY OF FLIGHT on the pace inside in hand attended early through solid splits, got engaged by DELIGHTFUL QUALITY three furlongs out, cut the corner into the stretch let out for the drive joined by the eventual winner three wide, dug in staving off a pair until headed nearing the eighth pole, kept on to the wire to garner the place. DELIGHTFUL QUALITY attended the pace early on from just off the inside, intensified the pressure on the leader three furlongs out, battled between foes from the quarter pole until the three-sixteenths, finished evenly through the final sixteenth safe for the show honors. WITHGREATPLEASURE broke in at the start brushing the near side stall, settled two to three wide towards the rear of a compact group, came under encouragement midway on the turn, angled four wide for home and made no headway. WILLET three wide towards the rear coaxed along from the half mile pole, shifted out a path three furlongs out placed to a drive, angled five wide in upper stretch and weakened in the drive.
