LADY ELI took up in position in midpack from off the inside, departed the backstretch from the four path, tipped a bit wider and unleashed a strong run from the five-sixteenths pole, turned for home with good momentum, powered her way to the front during the run through the furlong grounds, extended the margin maintaining her impressive kick to the end, ITSONLYACTINGDAD vacated the inside route heading for the end of the backstretch, picked up the pace fanning outward into the stretch, wound up towards the six path by the conclusion of the maneunver, came home with good energy to procure the place.
