Dark Bay or Brown Colt, (Mar), by Sea of Secrets - Beright by Gray Slewpy. Trainer Paasch S. Christopher. Bred by Victory Racing LLC(KY).

PRINCIPLE SECRET bobbled at the start, chased off the rail then outside a rival nearing the turn, bid three deep on the turn, took the lead into the stretch and drew clear under a tap of the whip and steady handling. GREAT HUNTER chased inside, came out in upper stretch, split rivals in midstretch and was second best. STORMELLO stalked the pace off the rail, bid between horses on the turn, put a head in front leaving the turn and just held third. HOT FLAME chased a bit off the rail, came out three deep into the stretch and was edged for the show. DIVIDE AND CONQUER allowed to settle outside, came a bit wide into the stretch and lacked the needed rally. MR. NEGOTIATOR off a bit slowly, settled inside chasing the pace, came out into the stretch and was not a threat. COBALT BLUE a bit slow into stride, settled off the rail, angled in some on the turn and did not rally. STELLA'S POSADA sped to the early lead, set the pace inside, dueled along the rail on the turn and weakened in the stretch.
