1½ MILES. (Turf) (2.272) STAKES. Purse \$150,000 BEWITCH S.(GRADE III) FOR FILLIES AND MARES FOUR YEARS OLD AND UPWARD. By subscription of \$150 each, which should accompany the nomination or by Supplementary Nomination of \$7,500 at time of entry (includes entry and starting fees). \$750 to enter and an additional \$750 to start, with \$150,000 guaranteed, of which \$93,000 to the owner of the winner, \$30,000 to second, \$15,000 to third, \$7,500 to fourth and \$4,500 to fifth. Weight: 124 lbs. Non-winners of \$60,000 twice over nine furlongs on the turf since October 6 allowed 2 lbs.; \$45,000 over nine furlongs on the turf since August 1, 4 lbs.; \$45,000 over nine furlongs on the turf in 2007, 6 lbs. The maximum number of starters for the Bewitch will be limited to twelve. In the event that more than twelve fillies or mares pass the entry box, the twelve starters will be determined at that time with preference given to graded stakes winners, then highest turf earnings in 2006-2007. Starters to be named through the entry box by the usual time of closing. A gold julep cup will be presented to the owner of the winner. Closed Wednesday, April 11, 2007 with 24 nominations. In the event that this race is taken off the turf it will be contested at Thirteen Furlongs on the main track. (Cloudy 75)

SAFARI QUEEN (ARG), reserved early and maneuvered near the inside, eased out three or four wide approaching the final turn, inched to challenge nearing the stretch, wrested command, drew clear and was kept to her task. BARANCELLA (FR) settled within easy striking distance near the inside early, eased out four wide approaching the stretch, loomed prominently for the final furlong but couldn't menace the winner while superior to the rest. MOON BERRY (BRZ) moved to a clear lead near the inside early, held on well for ten furlongs and weakened. MAXINE'S HYMN stalked the pace four wide to the final quarter and was empty. INDY TROUBLE raced in contention four or five wide and weakened approaching the final quarter. MAMA I'M HOME fought early restraint along the inside early, saved ground, swung out seven wide for the drive and never menaced.
