1½ MILES. (Turf) (2.272) STAKES. Purse \$150,000 GREY GOOSE BEWITCH S.(GRADE III) FOR FILLIES AND MARES FOUR YEARS OLD AND UPWARD. By subscription of \$150 each, which should accompany the nomination or by Supplementary Nomination of \$7,500 at time of entry (includes entry and starting fees). \$750 to enter and an additional \$750 to st art, with \$150,000 guaranteed, of which \$93,000 to the owner of the winner, \$30,000 to second, \$15,000 to third, \$7,500 to fourth and \$4,500 to fifth. Weight: 124 lbs. Non-winners of \$60,000 twice over nine furlongs on the turf since October 6 allowed 2 lbs.; \$45,000 over nine furlongs on the turf since September 3, 4 lbs.; \$45,000 over nine furlongs in 2008, 6 lbs. The maximum number of starters for the Grey Goose Bewitch will be limited to twelve with two also eligibles. Starters to be named through the entry box by the usual time of closing. A gold julep cup will be presented to the owner of the winner. Closed Wednesday, April 16, 2008 with 19 nominations. In the event that this race is taken off the turf it will be contested at Thirteen Furlongs on the main track. (Cloudy 80)

Bay Filly, (Feb), by Smart Strike - Martinique by Pleasant Colony. Trainer Arnold, II R. George. Bred by G. Watts Humphrey Jr.(KY). COMMUNIQUE unhurried for a mild, saved ground moving closer thereafter, angled out for a clear path at the leader with a furlong to go and closed well to be up in time. TEJIDA set a comfortable pace near the rail, increased her advantage when asked with less than a quarter mile to go but was outfinished. RISING CROSS (GB) close up along the inside, angled out once in the stretch but lodged only a mild late bid. FLAWLESS TREASURE outrun for a mile, advanced four wide into the stretch and closed well on the outside. PALMILLA angled in early when within striking distance, saved ground into the stretch, angled out a bit but lodged only a mild late bid. JIVE closest to the pace while off the inside, held on well to the stretch and tired. FINAL REFRAIN reserved three wide, made a mild run to the quarter mile marker but could not sustain the bid. SWINGIT within striking distance, held on well to the stretch and weakened. ERES MAGICA (CHI) outrun, dropped back through the stretch and was not persevered with late. MONTE CRYSTAL (PER) forwardly placed three wide, faded after 10 furlongs and was not persevered with late.
