1½ MILES. (Turf) (2.272) STAKES. Purse \$150,000 *GREY GOOSE BEWITCH S. (GRADE III) FOR FILLIES AND MARES FOUR YEARS OLD AND UPWARD.* By subscription of \$150 each, which should accompany the nomination.\$750 to enter and an additional \$750 to start, with \$150,000 guaranteed, of which \$90,000 to the owner of the winner, \$30,000 to second, \$15,000 to third, \$7,500 to fourth, \$4,500 to fifth and \$3,000 to be divided equally among sixth through last. Weight: 124 lbs. Non-winners of \$60,000 twice over nine furlongs on the turf since October 9, allowed 2 lbs.; \$45,000 over nine furlongs since September 7, 4 lbs.; \$45,000 over nine furlongs in 2010, 6 lbs. Starters to be named through the entry box by the usual time of closing. A gold julep cup will be presented to the owner of the winner. Closed Wednesday, April 14, 2010 with 22 nominations. In the event that this race is taken off the turf it will be contested at Thirteen Furlongs on the main track. (Cloudy 58)

LADY SHAKESPEARE tracked a dawdling pace while reserved, was patiently handled to the stretch, responded when asked for her best, moved quickly to the leader inside the final furlong and drew clear late. CHANGING SKIES (IRE) set a dawdling pace near the rail, picked up her pace when asked with three furlongs to go, maintained a clear lead into the final furlong, could not cope with the winner late but was clearly second best. SWEET AND FLAWLESS in hand along the inside, angled out to be four wide entering the stretch but lodged only a mild late bid. MAGICAL THEATER closest to the pace inside, held on well to the stretch and weakened. FLOATING HEART reserved off the inside, was no real threat while failing to respond in the stretch. A SHE'S ADORABLE could not menace. NEHANTIC KAT angled out in the initial quarter, was reserved for a mile raced three wide with three furlongs to go and was no factor.
