

EIGHTH RACE **Keeneland** **April 25th, 2013**

1½ MILES. (Turf) (2.272) STAKES. Purse \$150,000 BEWITCH S. (GRADE III) FOR FILLIES AND MARES, FOUR YEARS OLD AND UPWARD. By subscription of \$100 each, which should accompany the nomination or by Supplementary Nomination of \$7,500 at time of entry (includes entry and starting fees). \$750 to enter and an additional \$750 to start, with \$150,000 guaranteed, of which \$90,000 to the owner of the winner, \$30,000 to second, \$15,000 to third, \$7,500 to fourth, \$4,500 to fifth and \$3,000 to be divided equally among sixth through last. Weight: 123 lbs. Non-winners of \$58,000 twice or ver nine furlongs on the turf since October 5, allowed 3 lbs.; \$45,000 over nine furlongs since September 3, 5 lbs. The maximum number of starters for the Bewitch will be limited to twelve with two also eligibles. In the event that more than twelve fillies or mares pass the entry box, the twelve starters will be determined at that time with preference given to graded stakes winners (in order I-II-III), then highest turf earnings in 2012-2013. Starters to be named through the entry box by the usual time of closing. Keeneland will present a trophy cup to the winning owner. Closed Wednesday, April 10, 2013 with 32 nominations. In the event that this race is taken off the turf it will be contested at One Mile and Five-Eighths on the main track. (Clear 57)

STRATHNAVER (GB) was unhurried into stride, responded when roused with three furlongs to run, circled into the stretch seven wide, drifted in despite left handed urging, caught REGALO MIA a furlong out, wore down that one and edged clear late. The latter settled off of the inside, took closer order through the final turn, angled in and slipped through entering the stretch, forged command and fought on well but was unable to resist the winner. QUSHCHI (GB) settled saving ground through the opening six furlongs, angled out five wide to commence her bid, ranged up through the final turn, continued on well between horses, was put in tight late when her stable mate drifted in and settled for the show. KISSABLE (IRE) was unhurried into stride, got through and was making up ground. ALAURA MICHELE was reserved off of the pace toward the inside, tracked the pace in hand, shifted out nearing the quarter pole, but flattened between horses and faded. ANEGREEN (ITY) was allowed to settle, came three wide but went evenly between horses. SCAMPERING prompted the pace four wide to the stretch but faltered between horses. AND WHY NOT failed to respond. GATHERING pulled to the fore three wide, disputed the issue to the stretch but gave way readily once headed. DYNARAMA was close up four wide to the final turn and dropped out. REVELSTOKE trailed.
