ACTRESS, patiently handled early, advanced along the inner rail around the far turn, swung to the four path approaching the eighth pole, lugged in under right hand whipping when taking the lead inside the eighth pole and dug in late to prevail. LIGHTS OF MEDINA lacked speed, was four wide on the far turn, angled to the five path in upper stretch and rallied outside the winner. CORPORATE QUEEN, light steadied when breaking slowly, was well back for six furlongs, raced five wide entering the stretch and rallied outside rivals. TORRENT hesitated at the break, saved ground on the far turn, hugged the inner rail through the stretch, advanced to the eighth pole then flattened out. MOANA, three wide the first turn, chased the pace three wide around the far turn then failed to rally. TAPA TAPA TAPA saved ground setting the pace, came off the rail turning for home and gave way in the drive. SHIMMERING ASPEN saved ground stalking the pace, eased out to the two path leaving the backstretch, moved up in hand to bid for the lead leaving the turn, was set down in upper stretch and gave way the final furlong. SUMMER LUCK, two wide the first turn, advanced three wide the far turn then weakened through the stretch. DANCING RAGS saved ground the first turn and was not a factor. YORKIEPOOL PRINCESS was steadied in tight quarters near the three eighths pole then failed to recover. FULL HOUSE chased the pace two wide and faltered.
