7 FURLONGS. (1.231) STAKES. Purse \$100,000 BLUE AND GOLD S. FOR THREE YEARS OLD. Free nominations close April 7, 2010. \$250 to pass the entry box, with a guaranteed purse of \$100,000. After payment of 1% to all owners of horses finishing 7th through last, 60% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth and 2% to sixth. Supplemental nominations of \$5,000 will be accepted by time of closing of entries, all fees included. Entries close Wednesday April 14, 2010, by usual time of closing. Weight, 122 lbs. Non-winners of \$30,000 since March 1, 2010 allowed 3 lbs., such a race in 2010 allowed 5 lbs., a race other than maiden or claiming in 2010 allowed 8 lbs. Field will be limited to ten starters with four on the alternates list. Preference to stakes winners in order (Grade I, Grade II, Grade III), then stakes winners, then highest lifetime earners. Trophy to the owner of the winner. (Clear 53)

COMEDERO sat off the pacesetting CONFIDENCE CRISIS, moved to that one around the turn to take command with ease, quickly drew off and was ridden out through the stretch as much the best. TOBOGGAN SLIDE prompted the leaders in good position three wide along the backstretch, tried to rally along the inside on the turn, eased out some for the drive and while no threat to the winner, was easily second best. PLANTATION sluggish at the start, advanced along the rail, swung out four wide around the turn but was no match for the top two in the drive. KENS CAPE lugged out into the first turn, steadily moved up three and four wide, lacked the needed late rally. LION ATTACK with the pace just off the rail through the half, had little left for the drive. ESCROW KID bobbled just after the start, stalked the leaders four wide, tired. PROUD OF MIDWAY showed little, three and four wide. SILVER PIONEER never was a factor inside. CONFIDENCE CRISIS set the pace along the rail, stopped after a half.
