About 1 1/8 MILES. (Turf) (1.42) STAKES. Purse \$75,000 *BLUSHING K. DERBY H. FOR FILLIES AND MARES THREE YEARS OLD AND UPWARD.* Free nomination by Saturday, December 8. \$400 to enter and \$400 additional to start. Supplemental nominations will be accepted by 12.00 noon, Thursday, December 13 at a fee of \$1,500, which shall include entry and starting fees. \$75,000 Guaranteed of which 60% to the winner, 20% to second, 10% to third, 4% to fourth, 2% to fifth and 1% to finishers sixth through ninth. Weights to be announced Thursday, December 13. Starters to be named through the entry box by the usual time of closing. The maximum number of starters for the Blushing K.D. Handicap will be determined by rail setting. High weights on the scale will be preferred. Failure to draw into the race cancels all fees. A trophy will be presented to the owner of the winner. Closed Saturday, December 8, 2012, with 15 nominations. (If deemed inadvisable by management to run this race over the turf course, it will be run on the main track at One Mile and One Sixteenth.) (Rail at 10 feet). (Clear 62)

DAISY DEVINE moved out while in front during the initial straightaway, went three then two wide on the first turn, was well rated while setting the pace, extended the advantage while off the rail on the far turn, was asked in upper stretch, drew off into the final furlong and proved much the best while eased up. FOREST UPROAR settled while off the inside, was ridden along on the far turn, moved in second in upper stretch, drifted out near the sixteenth-pole and safely secured the place. FRANCISCA went four then three wide on the first turn, settled on the outside, was urged along while off the rail on the far turn and failed to respond while best of the rest. AQUAPAZZA was unhurried at the back while near the inside, saved ground through the far turn and also failed to respond. NECESSARY LUXURY was asked from the start, went four then three wide on the first turn, tracked the winner on the outside, chased three to four wide on the far turn, floated six wide at the top of the stretch and stopped. (Rail at 10 Feet)
