TOEWS ON ICE had good early speed and dueled inside, took a short lead on the backstretch, responded when headed into the stretch, fought back along the rail under urging to regain the advantage a sixteenth out and inched away late. MAC DADDY MAC broke out and bumped a rival, dueled between horses then outside the winner, put a head in front again into the stretch, battled outside that one through the final furlong, could not quite match strides late but clearly bested the others. I'MALREADYTHERE prompted the early pace three deep then stalked outside, continued alongside a rival on the turn and held third. DR. DORR stumbled then was forced in at the start, stalked inside, went between rivals leaving the backstretch and into the turn, was in a bit tight midway on the turn, continued just off the rail into the stretch and was edged for the show. STREET VISION stalked outside a rival then three deep between foes on the backstretch and into the turn, continued outside, entered the stretch three wide and lacked the needed rally. JURY broke in onto a rival, stalked the pace inside to the stretch and weakened. ON FIRE bumped at the start, went up four wide to stalk the pace, dropped back off the rail on the turn, gave way and was eased in the stretch.
