SOLDIER'S DANCER unhurried early, raced four wide around the far turn, then responded to pressure in the drive and rallied to be up late. **PICKAPOCKET** prompted the pace outside **MEAN SAX**, took over from that rival inside the eighth pole but couldn't resist the winner late. **MEAN SAX** well in hand while making the pace along the hedge to past the eighth pole, weakened. **LIVINGSTON STREET** tracked the pace along the hedge, eased out for room in the stretch and lacked a rally. **FEARLESS EAGLE** tracked the pace into the stretch and had no response when asked. **BLACK SCORPION** rank under restraint in the early going, stalked the pace three wide to nearing the stretch, then tired.
