**1 MILE. (1.353) STAKES. Purse \$100,000 BOURBONETTE OAKS (GRADE III) FOR FILLIES, THREE-YEARS-OLD.** By subscription of \$100, \$500 to enter and \$500 additional to start. Supplementary nominations may be made at the time of entry Wednesday, March 23, 2011 by payment of \$5,000 each (includes all fees). \$100,000 Guaranteed. After payment of 1% to all owners of horses finishing 6th through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth and 3% to fifth. Weight: 122 lbs. Non-winners of a Sweepstakes at a mile or over allowed, 2 lbs.; two races other than maiden or claiming at a mile or over, 4 lbs.; a race other than claiming at a mile or over since January 1, 6 lbs. This race will be limited to twelve starters. Preference to start will be given in the following order: Graded/Group Stakes Winners (in order I-II-III). Stakes winners, then highest career earnings. Starters and riders must be named through the entry box by the usual time of closing. Closed Thursday, March 17, 2011 with 28 Nominations. (Cloudy 40)

SUMMER SOIREE was away alertly and set the pace off of the inside, pulled clear after a half, remained unchallenged and drew away to score as the rider pleased. HARLAN'S RUBY stalked the pace four wide, failed to menace the winner but continued on well to prove second best. SUAVE VOIR FAIRE settled saving ground, worked her way out between rivals through the second turn, came five wide and was just up to earn the show. LILACS AND LACE attended the pace between horses, came three wide but lacked a response when called upon. KITTEN'S DANCER was unhurried into stride, made a belated gain circling seven wide but failed to threaten. MARION RAVENWOOD broke slowly, pulled to contention between rivals, but came up empty entering the stretch and faded. ANGELICA ZAPATA saved ground to little avail. READYBDANCING chased the pace three wide between horses for a half and retreated. TOUCH SCREEN showed little. PROUD HOUSE prompted the pace along the inside for five furlongs and stopped.
