FREE DROP BILLY was well placed early along the three path, became pocketed nearing the seven sixteenth pole, shifted into the three path entering the lane, took command of the lead and drew off late under a brisk drive. BRAVAZO chased the pace early from the five path, was just off the rail entering the lane while making a bold bid but was no match for the winner in the final stages. LONE SAILOR broke a bit slowly at the start and raced back early on along the four path, altered around foe near the five sixteenth pole, fanned into the seven path entering the lane and moved up in the stretch run. LIONITE came out at the start, stalked the pace early off the rail, steadied and avoided foe near the five sixteenth pole. shifted into the four path entering the lane and faded in the stretch drive. GIVEMEAMINIT was unhurried early along the three path, stayed in the three path entering the lane and improved position in the stretch run. EZMOSH was bothered at the start, fought restraint around the first turn while well placed along the four path, fanned into the five path entering the lane and was empty down the lane. CREA'S BKLYN LAW trailed the field early along the six path, shifted into the three path entering the lane and improved position. BOURBON RESOLUTION fanned into the seven path in the far turn and was tired down the lane. READY PROSPECTOR set the pace early while off the rail, steadied around foe near the five sixteenth pole and folded up in the stretch. LONE ROCK was in tight and checked hard in the first turn. TEN CITY tracked the pace early along the three path, took command nearing the five sixteenth pole soon went wrong, was pulled up and vanned off.
