WARREN'S JITTERBUG a bit slow to begin, chased outside a rival then just off the rail, came three deep into the stretch, drifted in some in midstretch, came out and rallied to the front three wide past the sixteenth pole, drifted out despite right handed pressure late and held. GOING FOR A SPIN broke inward and slowly, saved ground off the pace, came out past midstretch, bid between foes in deep stretch and continued willingly inside the winner on the line. SISTER KATE angled in and dueled inside, fought back on the turn and through the stretch and just held third. CAMILLE C chased inside then a bit off the rail, was between foes into the turn, came out in the stretch and just missed the show. HALO DOLLY pulled hard under a hold between horses then dueled outside a rival, battled gamely outside that one in the stretch and between foes in deep stretch a nd weakened some late. A JEALOUS WOMAN had speed three deep then drifted out and stalked off the rail, fell back some into and on the turn, was between foes into the stretch and weakened. MISS BECCA broke slowly, settled off the rail then outside a rival, went three deep leaving the backstretch and into the turn and did not rally.
