A supplemental nomination fee of \$650 may be made by closing time of entries; \$300 to pass the entry box and an additional \$350 to start. All entrants will be required to pay entry and starting fees. The purse to be divided 60% to the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth and 2% divided equally among the remaining finishers. 122 lbs. Non-winners of \$35,000 at a mile or over other than restricted stake allowed 2 lbs.; two races other than maiden or claiming, 4 lbs.; a race other than maiden or claiming at a mile or over, 6 lbs. DANCE QUIETLY sat patiently under a good hold in the pocket, bided time there until nearing the quarter pole, found ample room to sneak outward for the stretch drive, responded well when given her cue, fought her way to a clear advantage during the ensuing furlong and held sway, driving. MOONLIT MALIBU outthusted for early command, took up chase from the outside, angled three wide under encouragement into the stretch, wasn't good enough to overhaul the top one but continued on with good courage to secure the place. DARING REALITY widest of all on the second turn, fanned four wide into the lane and rallied willingly en route for the show. LAKE SONG saved ground throughout most of the running and lacked the necessary stretch response. QUEEN'S HARBOR lightly urged from the gate, turned back MOONLIT MALIBU to establish command, showed the way, well rated towards the two path until the quarter pole and gave way. BANDOLA taken hold soon after the start, raced along the outside and tired. ABA DABBLOR three wide around both turns, folded.
