LIGHTMYFIREBABY three deep early, angled in and stalked inside then a bit off the rail, came out into the stretch and rallied under left handed urging to get up late. CHRISTIANA'S HEAT stalked outside then off the rail, bid three deep into the stretch, gained the lead nearing midstretch and held on well but was caught late. NORTH RODEO close up stalking the pace between horses then outside a rival, bid between foes into and through the stretch and held third. TUTTA BELLA sped to the early lead, set the pace off the rail then angled in on the hill, fought back a bit off the fence in the stretch and was edged for the show. AMERICA'S FRIEND settled off the rail then angled in on the hill, came out leaving the hill and four wide into the stretch and improved position late. UNUSUAL SPIRIT was in a good position stalking the pace inside, remained on the rail in the stretch and lacked the needed rally. ROCKELLA settled outside then chased off the rail, came three deep into the stretch and could not summon the necessary response. STERLING MISTY chased outside then three deep on the hill and into the stretch and lacked the needed late kick. BACHELORETTE ONE unhurried outside a rival then a bit off the rail, angled in on the hill and could not offer the needed response. FREEBIEHADTHEMOVES stalked the pace inside, came a bit off the rail in the stretch and weakened. LAUREN C chased between horses down the hill, continued a bit off the rail into the stretch and also weakened. KALOOKAN YEAR broke in a bit, settled off the rail then inside, came out into the stretch and did not rally. Rail on hill at zero.
