TRIBESMAN sped to the early lead off the rail, inched away and angled in on the backstretch, set the pace inside, came a bit off the rail in the stretch, drifted out some but held on gamely under urging. JOHNNY EVES close up stalking the pace inside on the backstretch and turn, came out into the stretch and held second. PARTYWITHLARRYZ chased off the rail then outside on the turn, came six wide into the stretch and gained the show late. LITSGOODLOOKNGRAY chased between horses or outside a rival, continued toward the inside in the stretch and was edged late for third. BRO LO stalked between horses then outside, came five wide into the stretch and lacked the needed rally. BESTDRESSED saved ground chasing the pace, continued inside in the stretch and could not summon the necessary response. HIGH STANDARDS three deep early, settled off the rail, angled in for the turn, came out into the stretch and did not rally. YOUNG JOE stalked went then three deep on the turn and four wide into the stretch and weakened. TOPPER SHOPPER stalked between horses then off the rail, went between foes again on the turn and also weakened. ZURI MWANA chased outside, dropped back off the rail on the turn and was through early.
