By subscription of \$300 each to accompany the nomination. Closed with 13. Or by supplementary nomination of \$25,000 by time of entry. Closed with 1. \$1,500 to pass the entry box and \$3,000 additional to start, with \$300,000 guaranteed of which \$165,000 to the winner, \$57,000 to second, \$33,000 to third, \$18,000 to fourth, \$9,000 to fifth, \$6,000 to sixth, \$6,000 to seventh and \$6,000 to eighth. 122 lbs. Winners of two races of \$50,000, 2 lbs. additional. Non-winners of \$55,000 allowed 3 lbs.. Two races other than claiming or starter, 5 lbs. ntries. (Cloudy 65)

QIAONA lagged back outside a rival then a bit off the rail, came out leaving the second turn and four wide into the stretch, rallied under left handed urging, drifted inward some in deep stretch but surged late to get up nearing the wire. UNUSUAL WAY pulled between horses then stalked a bit off the rail or inside, came out into the stretch, bid alongside the pacesetter to vie for command, put a head in front in deep stretch and was caught late. MARKS MINE sped to the early lead, set the pace inside, came off the rail some into the stretch, fought back inside the runner-up through the drive and continued willingly but was outfinished. DOINGHARDTIMEAGAIN stalked three deep then outside a rival or off the rail, came three wide into the stretch and lacked the needed late kick. AWE GOLLY MOLLY chased inside then a bit off the rail, came out into the stretch and could not summon the necessary response. CLOUDY MOON four wide into the first turn, chased three deep, came four wide again into the stretch and lacked the needed rally. JADE WITH ENVY broke a bit slowly, saved ground off the pace, cut the corner into the stretch and improved position. AKISS FORAROSE saved ground stalking the pace, continued a bit off the rail leaving the backstretch, came out in the stretch and weakened. TILDE was awkwardly into stride, stalked a bit off the rail then inside on the second turn and also weakened. GOOD PARTY three deep into the first turn, chased between horses, dropped back just off the fence on the second turn and had little left for the stretch. HOME JOURNEY had good early speed and stalked just off the rail, was between horses leaving the second turn and gave way in the stretch. QIAONA wore calks.
