**REDRESSTHEBALANCE (IRE)** was permitted to settle early but was always within striking distance three wide, got fanned four wide into the stretch but responded with a steady rally and was up late. **MARKS MINE** stalked **REVIVE ME** under strong restraint early, was pulled to the lead after a half mile, drew clear on the second turn, looked defeated at the furlong pole but dug in gamely. **SWEET TESS** raced unhurried from the rail to the second turn, eased around **REVIVE ME** into the stretch, dropped back to the rail for the drive and closed steadily. **MACHA** was without any early speed while two wide to the second turn, circled rivals five wide to the stretch and finished full of run. **BUTTERFLY SOUL** lagged early and crossed to the rail then raced unhurried for a half mile, moved closer while easing out into the second turn, was forced four wide to the stretch, loomed a bold factor at the head of the lane and continued to close but lost some of her punch. **MY LIL SHAMROCK** was well placed three wide into the stretch, had her best bid at the furlong pole and hung late. **LUCKY MOMENT** lagged early from just off the rail, saved ground on the second turn but lacked the needed closing response. **JERRY'SHONEYCAROL** saved ground to no avail. **ISADAIYSBELLE** showed little. **REVIVE ME** set a lively pace but was through after six furlongs.
