Dark Bay or Brown Gelding, (Feb), by Flower Alley - Flower Forest by Kris S.. Trainer Tim Glyshaw. Bred by Eugene Melnyk (KY).
BULLARDS ALLEY was away in midpack, stalked the pace while racing two-wide on the clubhouse turn, commenced a three-wide move at the half-mile pole, reached the leader with three furlongs to race, shook clear in early stretch and drew off with authority. OSCAR NOMINATED raced in midpack, angled off of the rail entering the backstretch, was alone in the middle down the backstretch, commenced a two-wide bid at the 3/8ths pole, was three-wide in range with the leader entering the stretch but was no match and held place. FLAMBOYANT (FR) raced near the back, saved ground on the opening turn, was in midpack entering the far turn, angled two-wide at the 5/16ths pole, finished gamely and missed place. IDAHO (IRE) lacked early speed, raced at the back just off of the rail, came under a ride while saving ground on the far turn, angled out in the stretch and closed well. ERUPT (IRE) raced near the back on the outside, was three-wide on the clubhouse turn, was two and three-wide on the far turn while commencing a rally, chased on the outside and yielded for lesser shares late. CHEMICAL CHARGE (IRE) took back to trail the field quickly angling to the rail, saved ground, was asked midway around the far turn and passed tiring foes down the stretch. ENTERPRISING was away in midpack, settled near the back, was two-wide on the turn, trailed the field at the top of the stretch and passed tiring foes. POSTULATION showed early speed, stalked the pacesetter while racing two-wide on the opening turn, tracked intently down the backstretch, continued to race two-wide on the far turn, remained in contention turning into the stretch but weakened. MESSI (GER) got out to set the pace, maintained a reserved tempo down the backstretch, saved ground, was headed late on the far turn and tired down the stretch. JOHNNY BEAR showed speed, stalked the pace while racing on the inside, saved ground on the turns, began to drop back midway around the far turn, proved to be empty down the stretch, was eased up on late and walked off.
