PIONEEROF THE NILE pulled his way along between horses chasing the pace, moved up outside then off the rail on the backstretch, came three deep into the stretch, took the lead past the eighth pole, drifted in a bit and held on gamely under urging. I WANT REVENGE stalked outside a rival then between horses leaving the backstretch and on the second turn, also came three deep into the stretch, bid between foes past the furlong marker then inside the winner and continued willingly to the wire. CHOCOLATE CANDY settled outside chasing the pace, went three deep on the second turn and four wide into the stretch and gained the show. BITTEL ROAD four wide into the first turn, chased three deep on the backstretch and second turn, came four wide into the stretch and lacked the needed rally. AZUL LEON saved ground chasing the pace, moved up inside on the backstretch, continued along the rail on the second turn and into the stretch, came out off heels in deep stretch and could not offer the necessary response. AXEL FOLEY a bit slow to begin, settled outside a rival then just off the rail, came out into the stretch and was not a threat. MARK S THE COOLER angled in and settled alongside a rival then outside foes leaving the backstretch, came four wide into the stretch and did not rally. HYPE broke a bit slowly, saved ground off the pace, came out into the stretch, steadied off heels then split rivals in midstretch and failed to menace. FRUMIOUS sped to the early lead off the rail, angled in on the first turn, dueled inside, inched away nearing midstretch and weakened in the final furlong. J P JAMMER broke out a bit, pulled his way along toward the inside chasing the pace, continued between horses leaving the backstretch and into the second turn, drifted out a bit in midstretch and weakened. VENTANA angled in and dueled outside a rival, dropped back some in upper stretch and also weakened.
