UNZIP ME stalked three deep then outside a rival, came out leaving the hill and four wide into the stretch, rallied to the front under urging in deep stretch and proved best. WEST RULER chased between horses then a bit off the rail, went three deep leaving the hill and four wide into the stretch and just got the place outside foes on the line. SALTY SARAH had good early speed and dueled outside a rival, inched away and angled in on the hill, came out into the stretch, battled outside a rival in midstretch and between foes late and held third. ALWAYS IN STYLE broke a bit slowly, settled just off the rail, came out in upper stretch, split foes in deep stretch and again at the wire and just missed the show. SUGARINTHEMORNING moved up inside to stalk the pace to the stretch, bid along the rail in the drive and continued willingly but was edged for a minor award. CALIFORNIA NECTAR dueled off the rail then stalked on the hill, came out into the stretch and weakened some in the late stages. MELTARIB settled outside then alongside a rival, angled to the inside on the hill and lacked the needed rally. STRAWBERRY TART chased a bit off the inside to the stretch and could not offer the necessary response. ANTARES WORLD settled outside then dropped back alongside a rival on the hill and did not rally. WAVELINE broke through the gate before the start, stalked just off the rail then between foes leaving the hill and weakened. EVASIVE CHARMER chased outside, came out four wide into the stretch and weakened. Rail on hill at zero.
