RATTLIN GYSPY settled off the pace, went three wide on the turn, swung four wide into the stretch, rallied on the outside, closed strongly to get the lead outside the furlong marker then drew clear under steady handling. D'CATS MEOW was urged along while off the pace, raced four wide on the turn, dropped to three wide nearing the quarter-pole, made a bid in upper stretch but proved no match for the winner while able to get the place. RIGHT TO RULE chased the pace on the outside then three wide on the turn, made a bid near the five-sixteenths pole, vied past the three-sixteenths pole and weakened while able to hold the show. SWEETTOUCH was urged along while off the pace, raced a bit off the rail on the turn and failed to rally. SCILLY was ridden along in the back half of the field, saved ground on the turn and failed to threaten. NETWORKING was urged along near the back, saved ground on the turn, angled out in upper stretch and failed to reach contention. WILD ABOUT MARIE chased the pace through the turn and tired. SHESADOZER was hustled to the lead, set the pace on the inside, lost the lead near the quarter-pole and gave way. COSTLY was urged along near the back while on the outside, raced off the rail on the turn and was no factor.
