CHEPSTOW led the way in first turn then continued on top, came under challenge from GOODTIMEHADBYALL, continued to battle with rival into the lane, refused to be denied and dug in tenaciously to the wire. **GOODTIMEHADBYALL** raced off the early pacesetter, moved up to engage rival, continued to battle along the outside of rival in deep stretch, fought back determinedly then lacked final kick to move on. **CHISELED** moved up closer racing between rivals at the half mile marker, raced in aim three wide upper stretch and continued steady bid to the wire. **CAUSE I'M ALEX** raced off the pace, hustled up four wide approaching upper stretch, continued driving two wide at the furlong marker and gained position. **RICH DADDY** began to pick up the pace along outside leaving the backstretch, roused five to six wide at head of lane, continued in contention four wide at the eighth pole then finished evenly. **FRANCOIS** picked up the pace along outside three furlongs out, gained two wide in upper stretch then evened out in late drive. **PAPA PIG** was allowed to settle in the backstretch, hustled up three wide entering the final turn, moved out wider, continued bid but needed more for impact. **CHEECH THUNDER** was reserved racing near the back, showed response between rivals upper stretch, improved position but was not enough for late contention. **BOCA SCUTTLEBUTT** moved up closer along outside near half mile marker, continued stalking through the backstretch, came under ride in far turn then gaveway in the lane. **LEGACY DANSEUR** stalked the pace in the backstretch, continued in contention then weakened along rail. **NO BRAKES** raced in the back, urged up inside at head of lane and failed to move into contention. **VALID CONCEPT** raced off the early pace and failed to rally in the lane. **TOH'S GREY CAT** was unhurried in the backstretch and lacked response in the drive. **RACETRACK ROMANCE** charged gate before it opened then failed to come out.
