SIERRA SUNSET pulled between horses then stalked outside a rival, bid three deep on the backstretch and into the second turn, took a short lead outside a rival, inched away leaving that turn, responded when challenged again in the stretch and inched clear again under urging. MY REDEEMER four wide on the first turn, chased between horses, moved up outside a rival on the second turn and three deep into the stretch, bid outside the winner in midstretch, could not match that one but was clearly second best. HARLENE broke a bit slowly, settled outside, went three deep on the second turn and four wide into the stretch and gained the show. NEVADA WORRIER stalked a bit off the rail then outside a rival on the second turn and lacked the needed response. IF IT STAYS FAIR broke a bit awkwardly, chased between horses then off the rail, came three deep into the stretch and could not summon the necessary response. BERT'S LAW settled a bit off the inside, found the rail in the stretch and improved position. CALIFORNIA BLAZE pulled his way along to duel inside then stalked along the rail and weakened in the stretch. GUTS settled inside, came out leaving the second turn and into the stretch and lacked a rally. YOUAREFUN unhurried off the rail for six furlongs, came three deep into the stretch and failed to menace. BYJOHN saved ground stalking the pace, dropped back into and on the second turn and weakened. WARRENS ATTACK CAT settled outside, moved up four wide on the backstretch, continued three deep on the second turn and into the stretch and lacked a further response. FLIGHT LEADER chased outside then three deep, split rivals on the backstretch, continued three wide on the second turn and had little left for the stretch. WISE MANDATE pulled three deep to force the early pace, dueled between horses on the backstretch, battled inside the winner on the second turn, dropped back into the stretch and gave way.
