ROUSING SERMON chased a bit off the rail then between horses on the backstretch and second turn, came out three deep into the stretch, gained the lead under left handed urging alongside the runner-up a sixteenth out and pulled clear. MOTOWN MEN pulled a bit and sped to the early lead, set the pace inside, inched away again past midway on the backstretch, held on well until the sixteenth pole, could not match the winner thereafter but saved the place. STONEY FLEECE stalked outside, bid three deep midway on the backstretch, tracked the leader alongside a rival on the second turn and into the stretch and was edged for the place. BROADWAY NIKKA a step slow to begin, stalked off the rail, bid between horses midway on the backstretch, tracked the leader just off the fence on the second turn, drifted inward in the stretch and weakened. CHAMPIONS GATE broke outward, went up four wide into the first turn, stalked three deep, drifted four wide into the stretch and also weakened. UNVEILED HEAT pulled his way along and steadied off heels into the first turn, chased inside, went outside a rival on the second turn, came out into the stretch and did not rally. INQUISITIVE SON angled in and settled outside a rival then a bit off the rail on the second turn and into the stretch and lacked the necessary response. FAR TO REACH close up stalking the pace inside to the stretch, weakened in the drive. OUR BOY BENJAMIN angled in and chased outside a rival, dropped back just off the fence on the second turn and lacked a further response.
