COURTSIDE sped to the early lead outside a rival, angled in and set the pace a bit off the rail, inched away in the final furlong and gamely prevailed under some urging and strong handling. BOB BLACK JACK angled in early and stalked inside throughout, could not catch the winner in the drive but gamely edged a foe for the place. M ONE RIFLE was in a good position stalking the winner between horses until deep stretch and bested the others. LEGAL SEPARATION saved ground chasing the pace, came out leaving the turn and into the stretch and lacked the needed rally. CHILOQUIN chased alongside a rival then off the rail leaving the turn, came out into the stretch and also could not offer the necessary response while drifting in. FRUMIOUS close up stalking the pace three deep until midstretch, weakened in the final furlong. MENSA HEAT settled inside then a bit off the rail chasing the pace, came out some in the stretch and was not a threat.
