ROCA ROJO (IRE) came in slightly at the break and brushed with MISSISSIPPI DELTA, straightened and prompted the pace in about the four path and under rating, responded when given her cue leaving the far turn, ranged up and engaged BELIEVE IN BERTIE from her outside entering the lane, dueled, was brushed by that one while gaining a slim lead in mid stretch, continued the battle while racing on her left and got the bob at the line. BELIEVE IN BERTIE cleared early, set the pace under snug rating and well removed from the hedge, came under a ride nearing the lane, dug in once collared in upper stretch, wandered outward a bit under left handed rousing and brushed the winner, corrected and kept on gamely inside that one to just miss. LINDA settled in the clear while in the four path, angled out around the final turn and was put to pressure, circled six wide into the lane and continued willingly to outdo HILLHOUSE HIGH for the show. MISSISSIPPI DELTA came out a bit and hit the gate, brushed with the winner soon after, regrouped and moved up to a forward position after a quarter mile, raced four to five wide pursuing the leaders, gained slightly past the furlong grounds then flattened out late. PRIZE EXHIBIT (GB) settled off the pace, came four to five wide for the drive but failed to menace. HILLHOUSE HIGH stalked the pace three wide and to the inside of a rival, was ridden along past the five sixteenths. failed to kick on in upper stretch and gave way. HARMONIZE, off the pace and removed from the hedge, was under pressure leaving the far turn but failed to make an impact.
